WORKSHOP

Mike Turner provided a written report and stated that everything was going well. A new bathroom was added at the clubhouse to accommodate tournaments- it has two stalls and is a great improvement.

PRESENTATION BY CITIZENS

Cindy Gonzales the "Burrito Lady" gave Council a report on her food truck business. She has purchased a truck with the assistance of the Eden EDC. She is finalizing permits but should be ready for business this month; she is looking for a place to park it. Cindy asked if it may be possible to park on the square temporarily or she had talked with Celina who had suggested in front of the Green Apple. One of the needs is electricity and a restroom available. She will continue to look for a location other than City property and if need be she will get on the agenda for next month to discuss the City property.

REPORTS OF OTHER AGENCIES, COMMISSIONS & STAFF

Dan Choate from eHT gave a recap of the well project. The well has been completed with a successful cement job and they are in the process of drilling out the temporary plug. Josh Berry hill reported on the water treatment plant project and said that he had a very good meeting with the contractor ACP as well as WRT who will provide the treatment processing system.

BUSINESS

Anita Aguilar updated Council on Agenda item A- the upkeep of the Cemetery. She gave a recap of the past years from 2009- Fred Eureste took over as the job of manager of the "Mexicano Cemetery" as she called it. In June of 2010 a group of ten or more helped clean up the cemetery, 2013 was a rough year with individuals being sick, etc. They are trying to get the younger generations involved. Proposal form Mr. Phillip Kothmann regarding the use of the radio tower owned by the City with the lease agreement to be \$120 /year for ten years and that he repair and maintain the building and pay the monthly electric bill seconded by Councilperson Hall, motion carried.

Councilperson Hall made a motion to approve Business item D. February 2014 bills, seconded by Councilperson Spann, motion carried.
